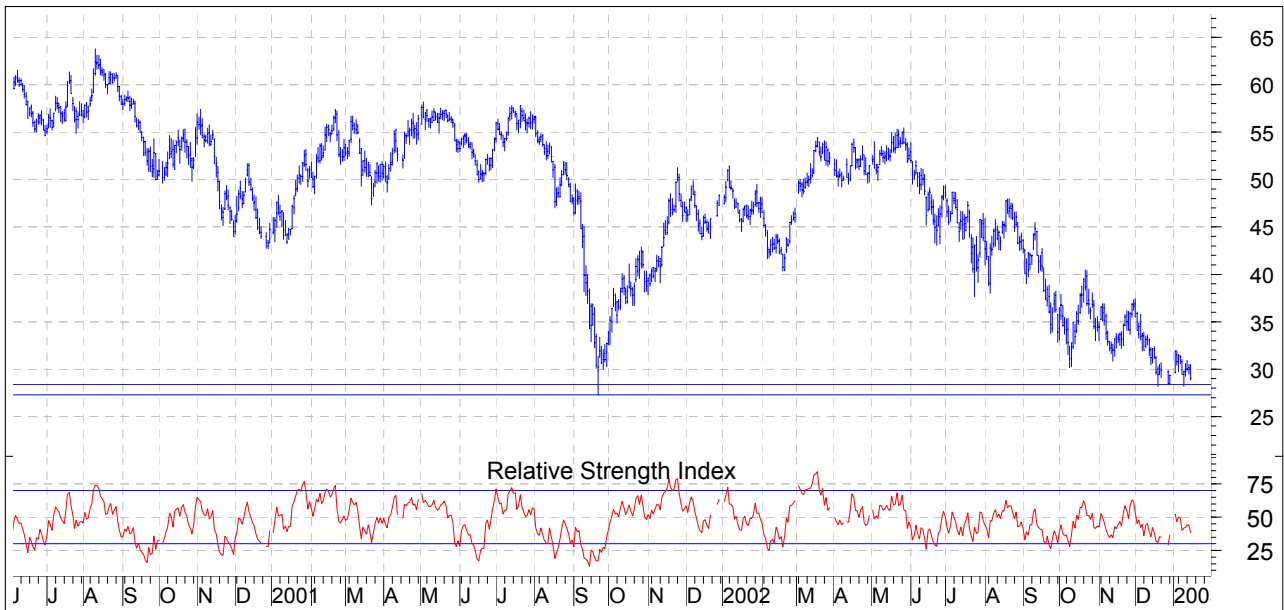

Summary

DCXX continues to pressurise major support at 28.2/27.24 (broadened). Recent consolidation above this area has served to unwind oversold constraints, thereby reducing the potential for recovery. A close below the Sep 2001 low of 27.24 would constitute a serious long term bearish breakdown, with continued weakness back to 23.8/23.5 expected initially.

Comment (See below for the implications of breaks of support and resistance areas)

A close above initial resistance at 31.32/32.24 would alleviate immediate bearish pressures, but in no way alter the overall bearish medium term chart structure. Only a close above 39.9/40.5 would cast doubt on the medium term bear trend.

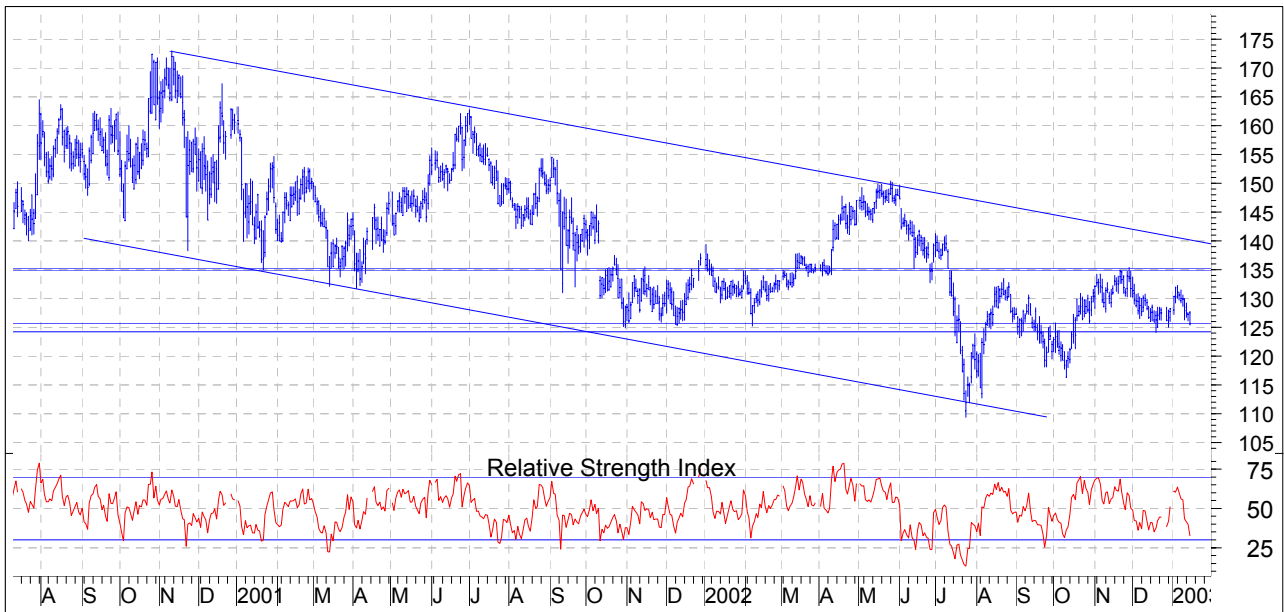

Summary

Now testing key support at 125.7/124.1. This area must hold closing values to prevent a well defined short bearish term top from being completed and further weakness back to 118/116.3. Lesser support at 121.3 may punctuate any such decline. A close above resistance at 135/135.4 would be needed to signal a move into bullish territory.

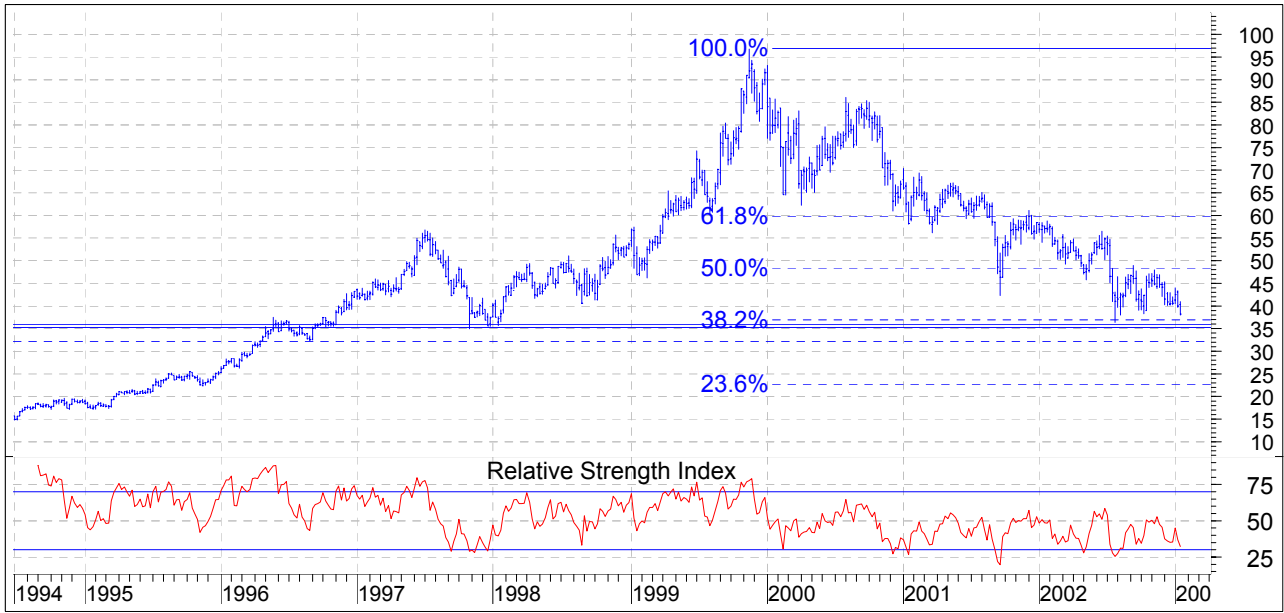

Summary

Now testing the first of two closely positioned support areas at 38.27/38 and 36.33/34.94. The latter band represents a major technical boundary which must hold to prevent a resumption of the major downtrend and further serious weakness (see below for targets).

However, momentum indicators are beginning to push into oversold territory, so bears should proceed with extreme caution whilst each of these support areas is being tested. Overhead, initial minor resistance now stands at 40/40.5. Clearance of the next resistance at 44/44.05 would be needed to give a bullish signal for the short term.

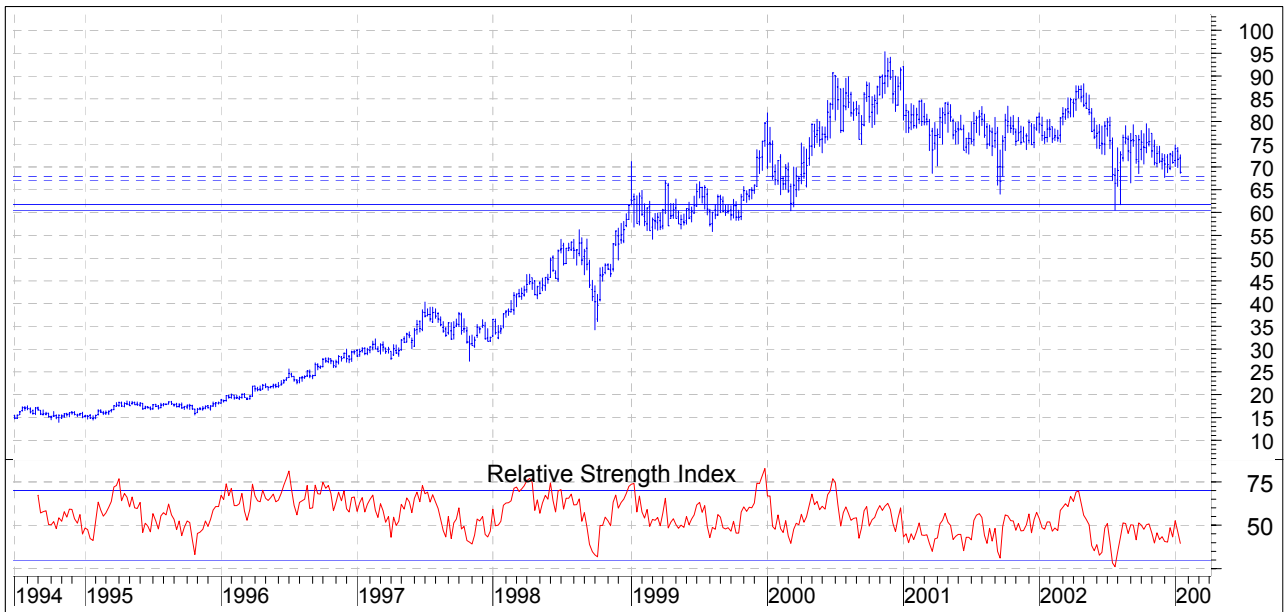

Summary

Evidence of long term topping activity continues to emerge. Yesterday's action broke support at 70.1, implying that the short term downtrend is accelerating and that a test of 67.7/66.5 is imminent. A close below 67.7/66.5 would constitute a strongly bearish breakdown pointing to further weakness back to 62.75/60.35.

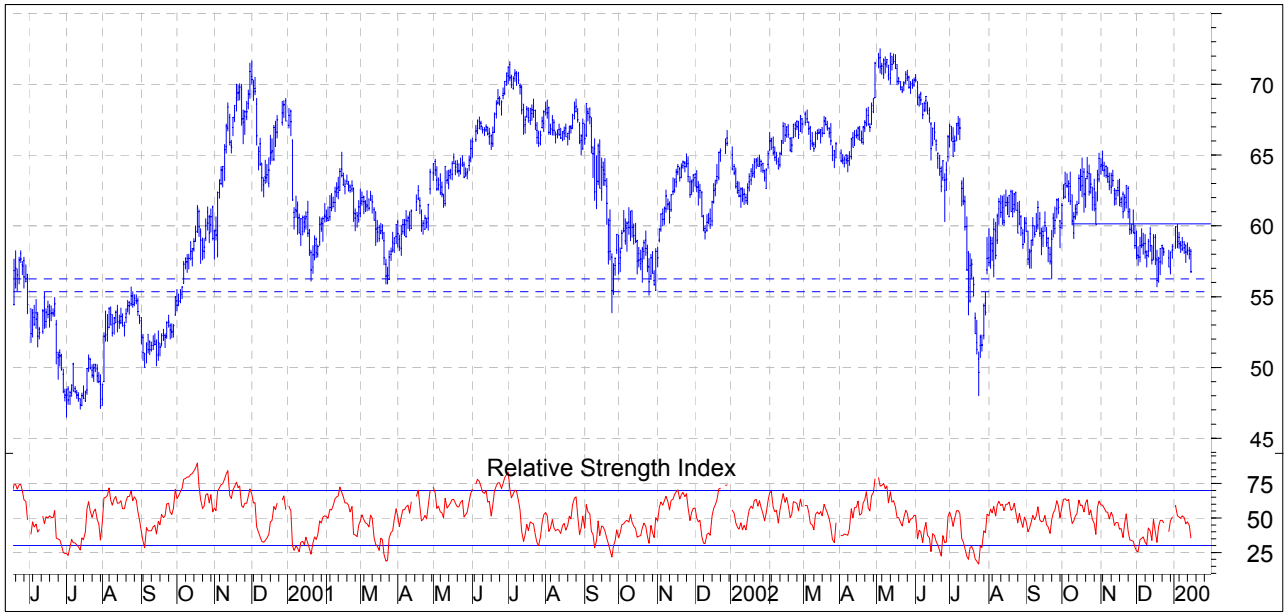
